

## **Friends of NRA 2025 Feedback Sweepstakes**

### **Official Rules**

**NO PURCHASE OR CONTRIBUTION OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE OR CONTRIBUTION WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**THE FRIENDS OF NRA 2025 FEEDBACK SWEEPSTAKES ("SWEEPSTAKES") BEGINS AT 10:00 AM EASTERN STANDARD TIME ON January 1, 2025 AND ENDS AT 4:00 PM EASTERN STANDARD TIME ON December 14, 2025 ("ENTRY PERIOD").**

**ELIGIBILITY:** By entering the Sweepstakes, you certify that you are eligible to enter into this Sweepstakes and agree to be bound by these Sweepstakes rules. Normal time rates, if any, charged by your Internet service provider will apply. There is a limit of one sweepstakes entry per person and per email address, regardless of method of entry.

No purchase or contribution of any kind is necessary to enter or win. You have not yet won. Odds of winning depend on the number of eligible entries received.
