OUT OF ALL YOUR LIFE ACCOMPLISH-MENTS, WHICH ONE STANDS OUT THE MOST TO YOU?

I've been blessed with so many amazing opportunities in my life, so it's hard to narrow it down to one. But I was recently honored with a commission that really seems to identify everything I've been working towards over the last twenty years. In May of 2018, President Trump appointed me to the President's Council on Sports, Fitness & Nutrition. I've been given the chance to represent people with disabilities and effect real change on their behalf on a national platform, and I couldn't be more excited. I am passionate about outdoor recreation and helping everyone to stay as independent as possible, so this new adventure is something that will always stand out to me as one of the best moments in my life.

* WHAT DO YOU SEE FOR THE FUTURE OF Shooting sports for those with DISABILITIES?

There has never been a better time to be living with a disability than right now, especially if you are interested in shooting sports and other adaptive recreational adventures. The NRA Adaptive Shooting Program was rebooted several years ago and is being led by Dr. Joe Logar. He is doing a phenomenal job providing education, resources, and leadership as the NRA seeks to better serve people with disabilities. Whether it's through competitive shooting, hunting, or recreational firearms activities, if you have the desire to participate, a disability shouldn't stand in your way. The future is bright, and the opportunities are endless.

WHAT MADE YOU WANT TO BECOME A MOTIVATIONAL SPEAKER & DO WHAT YOU DO TO HELP OTHERS EVERY DAY?

I certainly never planned on making a living as a motivational speaker, but after winning the 2013 Ms. Wheelchair USA crown, I was given the chance to travel and speak during my reining year. I quickly remembered how much I enjoyed sharing my story with others, as well as explaining what I've learned along this incredible journey. I was given more and more opportunities, and before I knew it, I was doing it full time. Every time I speak, I get to meet new people, learn about their lives, and share my passion for redefining moments and lessons we take from those times. I'm incredibly fortunate that my job never feels like work.

★ WHAT IS YOUR FAVORITE QUOTE & WHY?

"Sometimes it takes more courage to let go of old dreams that you don't even recognize anymore in order to move on to new dreams." This is something that I had to learn at an early age, but it has helped me time and time again as I am faced with obstacles and changes in my life. Many people believe that if you don't return to your life exactly as it was before a disability or major life change, future plans included, that your obstacle has somehow beaten you. I completely disagree with this. My life looks nothing like I had planned as a teenager, but I wouldn't change a thing.

★ SHARE YOUR FIRST RECOLLECTION OF USING A FIREARM. HOW OLD WERE YOU & WHO TAUGHT YOU HOW TO SHOOT?

I didn't grow up around firearms. I knew that my Dad stored a few guns in his closet, but he never got them out or taught me about them. When I started dating a boy from Wyoming in 2005, Russ made it clear that he couldn't marry me unless he knew I could shoot! Unfortunately, it wasn't a very pleasant experience. Although we did get married in 2006, I learned that your spouse isn't always the best person to introduce you to learning a new skill. Luckily, I was given another chance in 2013 when I drew my first bull elk tag. I knew I couldn't use a bow as I had on previous hunts, so I ventured into the world of firearms once again. I'd shot since that first encounter, but nothing serious. This time around it was an amazing experience, and I've immersed myself in firearms ever since. Learning about guns in my late 20's allowed me to appreciate them in a way I don't think I would have if I grew up around them. Teaching others and making sure their first shooting experience is a pleasant one is a passion of mine that will never fade.

AS AN OUTDOORS WOMAN, WHAT IS Your favorite outdoor activity & Why?

When my accident happened in 1999, I assumed, like many others, that people living with physical disabilities don't go outdoors. I've never been so happy to be wrong about something! The outdoors doesn't have to be a scary place, but you have to be brave enough to wheel outside of your comfort zone and venture out. Sometimes it takes a little bit of creativity, the right adaptive equipment, and the support of your friends and family, but in the end, it's always worth it! My favorite outdoor activity is definitely hunting. I get to enjoy nature, challenge myself physically and mentally, provide an amazing source of organic protein for my family, and share in the joys of conservation efforts around the world. And every time I hunt, I learn something new, which makes me a better hunter and educator. I don't know what I would do without hunting!

WHAT IS YOUR FAVORITE TYPE OF FIRE-ARM TO SHOOT?

I love to hunt large game, so at the end of the day, I'm a rifle girl. Because of my wheelchair, I'm not the sneakiest hunter in the world, so I've worked hard to become proficient at shooting at longer distances. I always try to get as close as possible to whatever I'm pursuing, but if that's not an option, I want to ensure I can still make an accurate, ethical shot from any distance. My new favorite firearm is my 6.5 Creedmoor Bolt-Action rifle topped with a NXS 5.5-22x56 scope. With a solid base, this flat shooting combination is a joy to shoot. I've spent hours at the range making sure I understand and trust every aspect of the setup, and I just took my first big game with it on a recent antelope hunt with my husband and daughter.



The Daniel Defense MK18 Pistol, equipped with the SB-Tactical SOB Pistol Stabilizing Brace, is a variation of the MK18 SBR, which has been extremely popular within the Law Enforcement and Special Operations communities. This firearm is classified as a Pistol and not a Short Barreled Rifle (NFA regulated items require ATF approval and a tax stamp). The Daniel Defense MK18 Pistol features the railed forend Daniel Defense currently provides to USSOCOM and a 10.3" Cold Hammer Forged Barrel, the same length commonly used for close quarters operations. The MK18 RISII features the Bolt-Up System and has been rigorously tested prior to fielding by USSOCOM. Also included in this package is a set of Daniel Defense fixed front/ rear iron sights.

OHIO ORDNANCE WORKS 1918A3 SLR .30-06

The Browning Automatic Rifle (BAR) model 1918 was developed by John M. Browning in 1917. Ohio Ordnance Works, Inc. manufactures a semi-automatic version of this rifle; 1918A3 (WWII version). The only one of its kind in production anywhere in the world, it is manufactured with some of the original USGI WWI and WWII parts. The heart of the 1918A3 is the receiver made from 8620 steel casting that has been carburized and induction heat treated. The castings are machined on state-of-the-art, CNC machining centers. Every rifle is fully assembled, inspected, test-fired and re-inspected under the direct supervision of our master armorer. The entire manufacturing process is accomplished at their facility in Chardon, Ohio.

If you're a target shooter, a hunter or a collector, this limited edition (one of only a thousand) lever action rifle is for you! Designed to perform in the field without sacrificing aesthetics, the Henry has the looks and performance to match. This beautifully finished rifle features a polished and engraved brass receiver and an attractive 24.5-inch blued steel octagonal barrel equipped with a folding ladder rear sight and a blade front sight, ensuring a good sight picture.

What really sets this limited edition beauty apart from other mere lever action rifles is that it features an engraving design that was inspired by an early Henry rifle that was engraved in the style of the legendary Samuel J. Hoggson in or around 1862. This style was chosen for this edition by the president of Baron Technologies, Inc. (BTI), David Baron, and the pattern is expertly executed by master engraver Rob Bunting (of BTI), with assistance from engraver Seth Karlak and artist Catarina Pech. The classic American scroll pattern is cut, not molded, and hand chased. Topping off this limited edition classic is a fancy American walnut stock with a brass buttplate.

D-DAY PRINT

2019 is the 75th anniversary year of D-Day. On June 6, 1944 U.S. and Allied Forces conducted OPERATION OVERLORD, the largest military landing in history. In order to honor the sacrifice and heroism of those who led the way to victory in Europe, on Veterans Day 2018, a group of *Friends of NRA* Volunteers and military veterans met to shoot the types of weapons those brave American heroes carried in battle. These included M1 Garands in .30-06, M1 carbines in .30 carbine, and M1911s in .45ACP. Each of the casings and bullets on this print were recovered from this memorial shoot. Featured on the left side is a depiction of the map presented to General Eisenhower at the end of D-Day, when victory was still uncertain. On the right a view from the bay of a Landing Craft, Vehicle, Personnel (LCVP) showing these Soldiers' first view of the Normandy beaches that morning. This individually numbered limited edition print is number 1 of 244 prints and is exclusive to *Friends of NRA* events.


> K im Schrotenboer may like his hounds small, but he stands with super-tall company when called upon to defend the Second Amendment.

Schrotenboer, of Grand Rapids, Mich., is both a beagle man and an ardent NRA Foundation supporter. Beagles, for the uninitiated, are those short-legged, lusty-voiced dogs that look like long-legged hounds left in the drier a little too long.

Schrotenboer started chasing rabbits with beagles under his father's tutelage, and began running dogs in field trial competition as far back as 1955. It's a longtime family sport, Schrotenboer said, one of those outdoor pursuits that gets in the blood and tends to stay embedded.

Still an avid field trial participant, Schrotenboer has been privileged to own "some good dogs," he says modestly. In fact, his beagles routinely turn out to be of championship caliber, with some in the beagle field trial hall of fame.

The Grand Rapids outdoorsman also judges field trials when he's



not participating. Each trial is simply an old-fashioned test of what beagles do best: A pair of the little hounds are released in good rabbit country, and then they hunt for and trail rabbits, bellowing their joy to the sky with each shuffling step, huge hearts pumping pure joy through small yet robust bodies.

When autumn rolls around, the Schrotenboer family leaves the rabbit fields to hunt some of the big deer on Kim's Michigan property. Wife Susie prefers indoor activities, but she's an understanding spouse when deer season rolls around.

"We plant food plots on our land and do our best to manage for trophy bucks," Schrotenboer said. "We only harvest mature bucks and let the younger animals grow. It's a practice that's really paid dividends for us. Most of the deer we take off our land are quality whitetails." Schrotenboer says he's among the semi-retired now, which means he has a little more time for hunting and being afield with his beloved beagles. It's time well earned following a long and successful career in the hotel and restaurant business.

As an NRA Foundation supporter for years, Schrotenboer plays his part in defending the Second Amendment through generous financial gifts to support it's programs. "Too many people aren't aware of what the organization supports," Schrotenboer said. "They're not aware of all the programs for women, kids and the handicapped. The folks at the top are a broad-minded, visionary group who do so much that goes unseen and underappreciated.

"Most of all, The NRA Foundation protects the things that so many of us cherish—the shooting sports, hunting and our Second Amendment right to keep and bear arms," Schrotenboer added. "Essentially, if



you believe in our Republic and a free way of life, then you have to believe in, and fight for, the Second Amendment. It's the one that guarantees the existence of all the others—the First Amendment, the right to assemble, freedom of religion, all the rights we tend to take for granted until they're threatened."

His strong belief in the right to keep and bear arms—the most basic right of all according to Schrotenboer—is why the Grand Rapids hunter donates generously to The NRA Foundation.

Most of all, Schrotenboer's generosity stems from a big heart. Like his little hounds that outperform dogs many times their size when rabbit scent tickles their nostrils, Schrotenboer lets his deeds do the talking. In the end his efforts, along with those of other Second Amendment supporters, tend to broadcast their message across great distances, keeping the hope of individual liberty loud and clear. \blacksquare



Program Profile NATIONAL NEWS

We live in a day and age where information is right at our fingertips. Whether you're checking the weather forecast for your next hunt, finding the closest gun shop, or just curious about how much a blue whale's tongue weighs (hint: it's as much as an elephant!), you can find just about anything via the internet. A major advantage of that accessibility and freedom is the growing opportunity to engage with organizations and communities to develop skills, interests, and qualifications through online courses.

Peter Churchbourne, Director of NRA Hunter Services, and his team have applied this idea to the hunting community and are developing an exciting new way to encourage a strong future for those traditions—what he says is "the most encompassing and engaging hunter education course in the world."

Recently, the program, which is supported by The NRA Foundation, received seven Telly Awards and two Horizon Interactive Awards for its free online course. The Telly Awards honor web commercials, film and video productions, and outstanding local programs. They are judged by more than 200 leading industry experts including advertising agencies, production companies, and major television networks. Annually they receive more than 12,000 entries from all 50 states and five continents.

In 2017, the Horizon Interactive Awards, a leading international media competition, announced its winners that highlighted the "best of the best" in interactive media production. NRA was honored to be recognized for the NRA Hunter Education website with a silver award in the training/e-learning category, and a bronze award in the instructional video category. "It was great to see the course recognized with so many awards. It's a tribute to the massive amount of detail, time, and money the NRA put into developing this course for future hunters," noted Peter Churchbourne.

The NRA Hunter Education program provides an online class that will allow a person to choose any state and take its hunters education course. It can be done in the comfort of one's home and taken at their own pace. The material can also be referred back to for questions or a refresher. Best of all, the course isn't just limited to a computer; it is also available on a mobile device. Currently, seven states have fully functional courses available at NRAHE.org, ready to train hunters in Connecticut, Florida, Oregon, New Mexico, Oklahoma, Texas, and West Virginia. To get a state involved in the NRA Hunter Education program, Peter encourages everyone to call their local agency and stress the state's demand for the program.

The concept first took shape in 2015 and coordination began to set up individual states' courses. To facilitate the expansion of the program, the course can be tailored to each state's specific rules and regulations with no extra cost to them. "Hunters are one of the most regulated sportsmen in the U.S.," Churchbourne notes, "so it makes sense to be as educated as you possibly can." The course's comprehensive and clear layout accomplishes that task and is sure to produce some of the safest and most educated generations of hunters thus far. Plus, with interactive modules, audio recordings, videos, diagrams, and images, the experience is a visual learner's dream come true.

Ultimately, the NRA Online Hunter Education Course provides the best method for teaching future hunters lessons they will remember for the rest of their lives. And, unlike other courses, the NRA course is completely free, encouraging new hunters to take the first step and making it easier for seasoned hunters to revisit the material. All there is to do is visit NRAHE.org, create an account, and begin your education!

New Beginnings in PA

> Founded in Imperial, Missouri, the Student Air Rifle program (SAR) has expanded to Iowa, Texas, and most recently, Pennsylvania. With a new support in the works between SAR and The NRA Foundation, the Student Air Rifle program is making leaps and bounds in its attempts to increase student involvement in the shooting sports.

Through incorporating SAR into schools, students are becoming more actively involved in target shooting activities. According to Jake Hindman, President, and CEO of SAR, "The Student Air Rifle program is a pivotal turning point in increasing student involvement in target shooting sports. Approximately 21-22% of our students had never participated in the shooting sports before coming into this program. The results are substantial. Not only does it teach safe shooting habits, but also grows confidence, which is crucial to youth development. It helps with focus, grades, and more, all of which are significant skills to tie into the school curriculum."

The program incorporates air rifle shooting into school physical education classes to ensure safe shooting practices for students in grades four through twelve. Based on the National Association of School Psychologists (NASP) model, SAR utilizes proven safety protocols, training methods, and equipment to offer students a fun and safe method of introductory shooting sports. Hindman adds, "This form of teaching is structured in a way that is even simple for the teachers or instructors to use."





Hindman notes, "We are looking for new states to get involved, and we are hoping for NRA volunteers to help out as well. For this program to succeed, it is important that community members become aware and involved with the program."

ith leading support from the *Friends of NRA* and dozens of partner organizations, 2,856 students and 561 parents and teachers participated in the Midwest Outdoor Heritage Education Expo, or MOHEE (pronounced MO'-hee), May 16-17, 2018 free of charge. That's a new record, compared to 2,704 students the prior year and 1,123 students in 2014, its first year at the Wisconsin Department of Natural Resources' MacKenzie Environmental Education Center near Poynette.

MOHEE is a unique field trip where students are face-to-face with live wolves, lynx, badger, otter, bison, and eagles while having the opportunity to participate in archery, airgun, fisheries, forestry, wildlife and other fun activities, all in one location. Many of these activities correlate with multi-discipline state and national education standards. Students receive information about on-going mentoring programs that allow them to develop their outdoor skills and enjoy lifelong outdoor activities. Educators, trained safety instructors, and other volunteer mentors provide an enriching participatory experience for students, connecting youth to Wisconsin's natural resources, outdoor heritage, and lifelong skills.

"Well worth the long drive, our students and colleagues plan this field trip every year," said teacher Jordan Williams of Scales Mound, Illinois.

"Best field trip ever," said Gwen Wohlgefahrt, a teacher at Jefferson Lighthouse School in Racine, Wisconsin, echoing what other school groups usually say about MOHEE. Wohlgefahrt and Williams traveled nearly five hours roundtrip with busloads of students eager to discover and try the more than 35 outdoor skills and activities. As a member of the media said,

Students arrive by the busload and experience things many would never have had a chance to try elsewhere. Every one of them, and their teachers left with big smiles on their faces.

Positive media coverage included a feature in the Milwaukee Journal-Sentinel and SCI HUNTERS magazine, plus social media support from teachers, students, and conservation group leaders who participate.

The biggest obstacle to success is the need for funding to cover growing expenses for buses and other costs. Most schools pay for their own transportation, but MOHEE's policy is to help cover costs for schools that would not otherwise be able to attend due to budget constraints. The policy is for no child to be left behind and indoors.

Historically, *Friends of NRA* has been, and continues to be, the single largest funding source of this event. *Friends of NRA* has donated six grants through The NRA Foundation, totaling nearly \$72,000 since 2015.

According to Mark LaBarbera, NRA Patron Life Member and head of the charitable, non-profit Outdoor Heritage Education Center which founded, owns and organizes the event, "MOHEE has helped more than 10,000 students and hundreds of adults in the last five years to take the first steps toward a lifetime of outdoor enjoyment. One of our key goals is to retain and reactivate hunters,





anglers, and others by getting them involved as instructors at this event and as mentors in ongoing outdoor skills programs for youth and adults." Another goal, he said, is to recruit students, parents, and educators into those programs.

"True mentoring is not a one and done event. MO-HEE creates awareness and offers huge numbers of people the opportunity to try various outdoor activities, and then tells them where to go for true mentoring programs that offer multiple learning experiences over extended time afield and at the range," states LaBarbera.

This all fits with the national R3 plan for recruitment, retention, and reactivation. State and national authorities on this subject believe this is one of the most critically important areas for the future of conservation and America's outdoor sports heritage. Conservation leaders agree that when everyone pitches in, the polarizing challenges can be overcome.

For 2019, MOHEE organizers are already redoubling efforts to increase numbers in a variety of areas. For example, they are planning to increase the number of schools, students, parents, and teachers who attend. MOHEE organizers intend to increase the number of activities, including shooting sports, falconry and aerial archery. They are also looking to add exhibits on bats, birds, and bugs.

Since 1990, The NRA Foundation has funded over 49,000 grants and awarded over \$398,000,000 to various shooting sports programs across the country. Many of these programs promote youth education and involvement to ensure a prosperous future for both shooting sports and the Second Amendment.

Two programs that have received such grants can be found in the very Northwest corner of the Texas panhandle in Dallam and Hartley County. Four years ago, both counties added a shooting sports program to their local 4-H clubs. They have since received a combined total of over \$50,000 to support the growth of shooting sports in their communities.

For any shooting program to find success, the right practice equipment and competition equipment is vitally required. Thanks to NRA Foundation grants, both the Dallam and Hartley County 4-H shooting clubs have obtained skeet throwers, trap throwers, gun safes; and most importantly guns, ammunition, and targets. While it may seem that the last three items on that list are obvious to the success of a shooting team, many may not realize that the price of those same three items can often inhibit young shooters from participating. However, by receiving grant money to pay for those necessities, the participation cost for every child is reduced.

"We want to allow as many kids to be involved as possible, and not all families can afford to buy targets and ammunition. That's why we love getting the grants because they allow kids to participate that otherwise wouldn't be able to," explains Stephanie Frantz, Chairman of the XIT *Friends of NRA* and the proud mother of two boys involved with the local 4-H shooting sports program. While in the 4-H program, kids learn how to properly and safely handle a variety of firearms; how to participate in shooting sports competitions; the laws and ethics related to shooting, hunting, and firearm use; and possible careers in the world of shooting sports and firearms. Kids also gain the skills needed to be proactive forces in their communities such as leadership, sportsmanship, and stewardship.

At every XIT *Friends of NRA* event, the shooting teams are sure to be seen assisting wherever they're needed; whether that's helping with food, or simply engaging in the conversation regarding their Second Amendment rights.

Yet however grateful these two 4-H programs are for the NRA, the NRA is even more grateful for their support. Without these programs promoting youth participation in shooting sports, the future generations would not have an understanding or passion for the Second Amendment, and would therefore not see the importance in protecting it. "I "is for TEAMD!

The Bonner County Sportsmen's Association (BCSA) of Sandpoint, Idaho is one of those "little gun clubs with a big heart." They not only talk the talk, but they walk the walk when it comes to passing on to future generations the uniquely American tradition of our firearms freedoms and marksmanship. They are the hosts of the Sandpoint JR Rifle Team, and also host a two day "Youth Day at the Range" event every year in June. This event supports local 4-H shooting matches and is heavily invested in the Idaho Department of Fish and Game Hunter Education program. But they still did not feel like they were doing enough!

The cadre of Range Safety Officers (RSO) for the Bonner County Sportsmen have story upon story of husbands who bring their wives up to the range for the first time and try to teach them to shoot. More often than not, it does not go well! The RSOs realized that there are a lot of women in North Idaho that want to learn how to safely handle and shoot a firearm but that they had nowhere to go and the husbands/boyfriends were not getting the job done. The BCSA had several programs directed towards youth shooters but had nothing for the lady shooters. That is when they decided to act.

President Bill Moody and Lead Trainer Tom Harvill contacted NRA Field Staff with their dilemma and their desire to come up with something for women who wanted to learn to shoot. They were directed to the NRA Women On Target® (WOT) program which is a one day, ladies only, firearms clinic that focuses mainly on the fundamentals of gun safety and marksmanship. PERFECTION!

Bill and Tom quickly realized that they were going to need help if they wanted to do this right, so they called master organizer Cathie Malison. Cathie is one of those ladies that could've organized the Desert Storm invasion and would have finished on time and come in under budget. When Cathie says she will handle something you never have to check back because it is HANDLED! She is also an avid bear and elk hunter, an ID CCW holder and an NRA Life Member. PERFECTION again!

Bill, Tom, and Cathie sat down together to figure out what they wanted to accomplish. They all agreed that the goal would be to offer the best firearms training possible at an affordable cost. To do this, they decided to cap the WOT class size to ten students so that they would have a lot of hands-on instruction and coaching from the RSOs. The BCSA Women on Target team maintains a two student per one RSO/Trainer Coach so that the ladies can get their questions answered quickly.

They also wanted their Women on Target class to be welcoming and inviting from the moment the ladies stepped through the door. Knowing that for many, this would be their first interaction with the NRA and the BCSA, Bill, Tom, and Cathie did not want to miss the opportunity to make a great first impression. Before each WOT Clinic in Sandpoint, the classroom, range, and facility are cleaned top to bottom, all the classroom tables have tablecloths, a dish of candy and teaching aids are placed at each setting, and everything is in place before the students arrive. A catered lunch, snacks, and drinks are all provided for the students.

They also wanted to provide the ladies with a chance to shoot several different firearms during the clinic, so each Range Safety Officer brought in their personal handguns in either .22, 9MM or .38 Special. There is everything from Glock, S&W, Kimber, Canik, Taurus, Colt, to Ruger's, and Sig's available for the ladies to try once they have shown proficiency in safe gun handling. This is sort of a "try before you buy" for the students, as not all guns fit all hands and the students can see what they like before they go to a gun shop. They also allow attendees to bring their own personal handguns if they would like coaching and instruction with the gun they already own.



The best way to accomplish these lofty goals was to divide and conquer. Bill, Tom, and Cathie did just that: Cathie took over registration, advertising, lunch, snacks, and drinks. Tom took charge of the classroom instruction, the classroom set up and making sure they have enough and a variety of handguns for the students to use, as well as procuring the ammunition. And Bill took over securing the Leo Hadley Indoor Range (BCSA fully donates the use of the Indoor Range to the WOT Team!), recruiting Range Safety Officers and running the shooting portion of the clinic. Bill recruited Gene Gibson, Jim Bonn, Frank Visger, Zeb Platt and Kelly Harliker as Range Safety Officers/ Trainer Coaches. The Bonner County Sportsmen's WOT Team has several centuries of combined firearms training and experience!

With all of their pieces in place, the BCSA WOT Team decided to host their first class in April of 2018. Needless to say with all their pre-planning it was a MAJOR SUCCESS! So much so, that all the ladies in the first class told all of their friends and Cathie started getting calls and emails to see when the next WOT clinic was going to be held. They hosted another one, and the same thing happened! So instead of trying to fight it, the BCSA team decided to host one WOT clinic a month for the foreseeable future! "We must be doing something right because the demand for this clinic is growing," said Cathie.

"The women that attend have been telling samily andpriends, and we have not had to do much advertising to fill our classes."

Each clinic starts with over four hours of training in the morning, where the women are taught about the parts of a firearm and how they function, how to safely handle a firearm, as well as how to load and unload several different types of firearms. Then, the ladies get nearly two hours of trigger practice. "They start by loading one round from the sitting position, then multiple rounds from sitting position. Then they shoot from the standing position, again starting with one round and progressing to multiple rounds; they do this with each caliber," said Tom. "Each class shoots a brick of 22LR, about 500 rounds of 9mm, and 200 rounds of 38 special. They get trigger time!"

The women that come to the clinics chose to attend for different reasons. Some want to learn how to improve their shooting and handling skills, while others have never touched a firearm and want to learn the basics. "The majority of women say that they attend for personal safety. Knowing the basics about firearms has also been an important reason to take the class. Many women have firearms in the home, as their spouse and/or older children are shooters or hunters. Knowing how to handle a firearm properly should they be exposed to one is a priority," said Cathie Malison. Others use the clinic as an opportunity to shoot a variety of firearms to find one that fits them well, and that they will be comfortable using. With the Bonner County Sportsmen's Association donating the use of the indoor range, and a crew of volunteers, the cost per student is only \$30! This includes all the instruction, lunch, drinks, snacks, and ammunition.

Offering the opportunity to take a low-cost, all-inclusive class has opened the shooting sports up to the women in their community, who can now learn about firearms and the shooting sports without having to make a huge investment. These clinics are empowering the women in Bonner County to feel safe being around and handling firearms. According to lead trainer Tom Harvill, "One of my personal goals is for the ladies to be safely handling firearms, hitting the target, and laughing and smiling; we have reached this goal with every class."

None of this would have been possible without the Bonner County Sportsmen's Association, the Idaho *Friends of NRA*, The NRA Foundation, and the NRA Women on Target program. Support from The NRA Foundation made the range improvements possible, allowing the Bonner County Sportsman Association to give back to their community by safely training women how to use firearms. Since 2009 the Bonner County Sportsmen's Association has received five grants totaling over \$41,000 to upgrade the Leo Hadley Indoor Shooting Range in Sandpoint, Idaho.

EMPOWERING WOMEN Through Education

In 2010, The CALGUNS Shooting Sports Association (CGSSA) was founded to maintain, exercise, and advance the Second Amendment within their southern California community. Founded by a group of volunteers, the organization has worked diligently to become a certified 501(c)(3) organization. CGSSA empowers California gun owners through education and community development events.

In 2010, CGSSA launched their first ever Women on Target event. The event was a big success with over 100 clinic attendees and 50 instructors coming out. Since then, CGSSA has held regular monthly clinics. These unique classes are targeted towards women who seek to empower themselves through the use of their Second Amendment freedoms. Generally, a group of about 16 women attend the clinics where they are trained in rifle or pistol usage. Women on Target also has a shotgun curriculum that CGSSA hasn't incorporated into thier cycle yet. "We found that women like pistols, so pistol classes dominated our yearly offering. We offer three rifle and nine pistol clinics every year. We do not combine firearm

types; a pistol class is just for pistol and the same for rifles," explained Jacob Rascon, President of CGSSA. Throughout the course of the clinic, participants are taught safety, mechanics, and firearm usage and ownership.

A big milestone for CGSSA came recently as the association hosted a basic firearm safety and shooting class for an entire Girl Scout troop. The troop, made up of about 20 girls, had a day full of fun and education. Jacob said, "It was a blessing to see this many young people and their families come together in support of the Second Amendment."

For almost a decade, CGSSA has teamed up with *Friends of NRA* to support their fundraising efforts. Since 2012, CGSSA has donated Women on Target class passes and other auction items to all southern California *Friends of NRA* events. Through their support of *Friends of NRA* Jacob learned about The NRA Foundation's grant program. CGSSA has received three grants from The NRA Foundation totaling over \$18,000 in grant product. The organization has been using these grants to make classes more accessible to all members, as well to help get the word out about the positive effects CGSSA has on the Southern Califoria community.

When asked why CGSSA has been so supportive of *Friends of NRA* over the years, Jacob replied, "The CALGUNS Shooting Sports Association board believes in God, Family, and Country. We believe in a safe and respectful shooting sports community. We believe everyone in our 2A community is important, so we have made it our mission to help them thrive. For the CGSSA board, this means teaching responsible ownership and firearm safety, while offering opportunities for learning, practice, competition, and firearm information sharing."
